- 1. Proposed Bill No. 3485 – P.Z. 13-2023 17551, 17555 & 17599 Chesterfield Airport Rd. (Baldrige-Ryken, LLC):** An ordinance amending the zoning ordinance 2724 of the City of Chesterfield by changing the boundaries of the “PC” Planned Commercial District to a new “PC” Planned Commercial District for a 2.9 acre tract of land located on the north side of the Chesterfield Airport Road of the intersection of Long Road and Chesterfield Airport Road (P.Z. 13-2023 17551, 17555, & 17599 Chesterfield Airport Road (Baldrige – Ryken, LLC) (17U140252, 17U140263, and 17U140203) **(Second Reading) Planning and Public Works Committee recommends approval with Green Sheet Amendments.**
- 2. FSP 59-2023 AMEREN (14490 Conway Rd):** A request for a new Facilities Siting Permit to install a new wireless telecommunications monopole located at the Union Electric Company site south of Conway Road and north of North Outer 40 Road (Ward 2). **Planning and Public Works Committee recommends approval with one condition.**

X. REPORT FROM THE CITY ADMINISTRATOR – Mike Geisel

- A. Gamble Schlemeier Success Contingency PAYMENT –** A request to approve a \$10,000 transfer from the General Fund Reserve in order to fund

the payment of the contingency “success” payment associated with obtaining the \$2 million ARPA grant from the State of Missouri, and as contracted in May of 2021. **(Roll Call Vote)**

B. Bid Recommendation – Miracle Field Resurfacing –

Recommendation to accept the bid in the amount of \$286,820 as submitted by Kiefer USA including a reimbursement upon completion to replace the original synthetic infield surface on Miracle Field at the CVAC. This project is funded by a municipal parks grant. **(Roll Call Vote) Department of Park, Recreation and Arts recommends approval.**

C. Bid Recommendation Bid Recommendation – Recommendation to accept the only bid received for the Independence Day pyrotechnic display, in the amount of \$55,000 as submitted by J&M Displays including the option to renew annually for an additional two years under the same terms and conditions. J&M Displays has successfully provided the annual pyrotechnic display in prior years. **(Roll Call Vote) Department of Park, Recreation and Arts recommends approval.**

Proposed Resolution No. 495: A Resolution urging Senators and Representatives of the Missouri General Assembly to oppose any legislation or proposal to eliminate the taxation or retail sales on food. City Administrator recommends approval. **(Roll Call Vote) The City Administrator recommends approval.**

Proposed Bill No. 3487 – Legends at Schoettler Pointe: An ordinance providing for the approval of a Record Plat and escrow agreements for Legends at Schoettler Pointe Subdivision, a 9.0-acre tract of land zoned “PUD” Planned Unit Development District located on the south side of outer 40 road and east side of Schoettler Road. **(First & Second Reading) Planning Commission recommends approval.**

C. Proposed Bill No. 3488 – Scarborough West, Lot 302 & Lot 303: An ordinance providing for the approval of a Boundary Adjustment Plat for Lot 302 and Lot 303 located on Chermoore Court in the Scarborough West subdivision (20R240388, 20R240379). **(First & Second Reading) Department of Planning recommends approval.**
