MINUTES

1. The meeting was called to order at 5:30 PM by Chairman, Councilmember Aaron Wahl.
2. Roll Call

Councilmember Aaron Wahl, Ward II (Chairman), Councilmember Dan Hurt, Ward III, Councilmember Merrell Hansen, Captain Cheryl Funkhouser, and Chief Ray Johnson.

3. Minutes – October 17, 2022

Councilmember Hansen motioned and Councilmember Hurt seconded to approve the minutes of the October 17, 2022 meeting. It was noted that the minutes reflected the request of Councilmember Dan Hurt to discuss the installation of a bullet proof glass safety barrier at the customer service representatives' front desk of City Hall and that item does not appear on the agenda for the meeting this evening. Chief Johnson informed the Committee members that the costs were not yet available so this issue was not placed on the agenda. Councilmember Hurt asked that the issue be placed on every future agenda until it is discussed with a final motion from the Committee. The minutes were approved 3-0.

4. Proposal for Satellite Office – St. Louis County Prosecuting Attorney

Chief Johnson described a planned project to establish a County Prosecuting Attorney satellite office at Chesterfield City Hall. This office would operate on a trial basis two days a week and allow officers and resident victims/witnesses access to the St. Louis Prosecuting Attorney staff without travelling to Clayton. The Prosecuting Attorney assigned to Chesterfield would occupy an office near the Municipal Court area and would provide his/her own cell phone and laptop computer and printer, and would require nothing other than use of desk space and access to Wi-Fi. The prosecuting attorney would not have/require access to the City computer network. Chief Johnson informed the Committee members that Municipal Prosecuting Attorney Tim Engelmeyer is supportive of these plans.

Councilmember Hurt inquired about cost and any revenue to the City. Chief Johnson replied that there no direct costs or revenues but the convenience to officers' time when applying for warrants would be an asset.

Councilmember Hansen motioned to recommend approval of the proposal. Councilmember Wahl. Seconded. During discussion, Councilmember Hurt recommended that there be a yearly review of this proposal. Chief Johnson replied that this is a verbal agreement with the St. Louis County Prosecuting Attorney's office and the City of Chesterfield may pull out at any time.

The motion carried 3-0. This item will be placed on the next City Council agenda.

5. Deer Sampling Survey

Chief Johnson briefed the Committee members on the intent of the Police Department along with the Public Works Department to conduct a deer sampling survey. The last survey was done in 2019. This survey will give an idea on the deer population within the City of Chesterfield. The survey will follow guidelines of the State Department of Conservation and the outcome used for future planning for control of the deer population. There was no action by the Committee required regarding this item.

6. Councilmember Wahl reminded Committee members that the Alternative Court proposal will be discussed at the Finance & Administration meeting on Monday, December 12th.

Deer Distance Sampling

2023



Background

In January of 2018, the City of Chesterfield contracted with White Buffalo, Inc to conduct an estimate of the deer population in the City. White Buffalo personnel employed a technique called “distance sampling” to compile the data for their report. Distance Sampling consists of field observations made of deer in a specific identified transect. The main observations consist of the number of deer observed along this transect and their distance from the transect.

In January of 2019, the City of Chesterfield decided that a second distance sampling project would be completed to compare to that which was completed by White Buffalo in 2018 to determine changes, if any, to the deer population within the city. In the survey conducted in January 2019, City of Chesterfield employees were used to conduct the survey in place of White Buffalo, Inc personnel as a more cost-effective measure to gather this information.

This year the City of Chesterfield once again utilized city employees to conduct the survey. The employees selected for this project were Officer Ryan Broeker, Officer Tyler Lewis, Officer Edmund Sosuh and Officer Kyle Tyndell. Officer Tyler Lewis participated in the 2019 count and was assigned as the team leader for the current survey. In 2019 employees met with Erin Shank of the Missouri Department of Conservation and received training, resources, and guidance from her prior to undertaking this project. Ms. Shank has worked closely with both White Buffalo, Inc and other area agencies in the past on deer sampling projects and is very knowledgeable about the procedure of conducting such a project. Officer Tyler Lewis has an extensive background in deer harvesting and is very familiar with the patterns, behaviors and identification of deer. This proved to be helpful when completing this assignment.

Methods

The officers assigned to this detail used the same techniques as were employed by those in the 2019 survey, which mirrored the 2018 survey conducted by White Buffalo. These techniques included traveling the same routes, using the same pattern of travel along those routes and dedicating the same amount of time traveled along those routes as the personnel in January of 2018. (See attached items 1-5 for maps of those routes) Their efforts mirrored every practice demonstrated by the City of Chesterfield employees in 2019. They conducted their research over the course of three 8-hour days. As a point of note, the White Buffalo, Inc survey was conducted during the second week of January in 2018 and the first City of Chesterfield survey was conducted during the fourth week of January in 2019.

The current City of Chesterfield survey was conducted on January 12-January 14, 2023 between the hours of 9:00 pm – 05:00 am each evening. These dates corresponded with 2018's dates. The survey was conducted using a marked City of Chesterfield Police vehicle, occupied by the four aforementioned City of Chesterfield employees. The employees served the roles of driver, front passenger operating a hand-held spotlight, rear driver's side passenger operating a hand-held spotlight, and rear passenger side occupant who acted in a data recorder / observer role. The driver's sole focus was safe operation of the vehicle and maintained a speed limit of approximately 10 mph throughout the duration of this project. As the other employees observed deer, the vehicle was brought to a stop perpendicular to the deer to obtain a yardage measurement of the distance to the deer. The yardage was determined using a hand-held range finder. This distance, as well as the number of deer in the grouping, was then recorded.

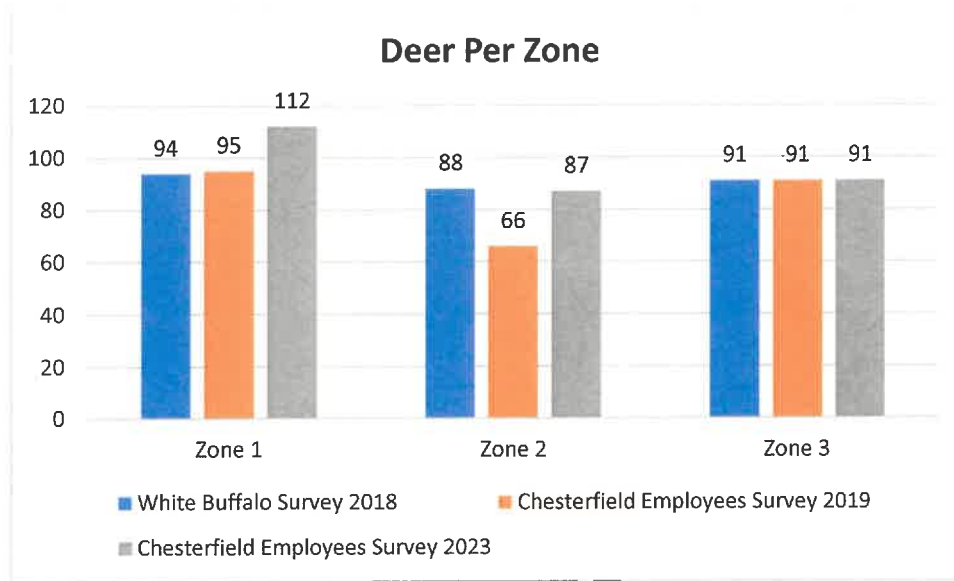
The weather conditions during the 2023 survey dates were as follows:

- January 12, 2023, air temperature 31-29 degrees, passing clouds with wind out of West/Northwest at 15-29 m.p.h.
- January 13, 2023, air temperature 21-14 degrees, passing clouds with wind out of the West/Northwest at 3-6 m.p.h.
- January 14, 2023, air temperature 34-40 degrees, passing clouds with wind out of the East at 3-7 m.p.h.

Results

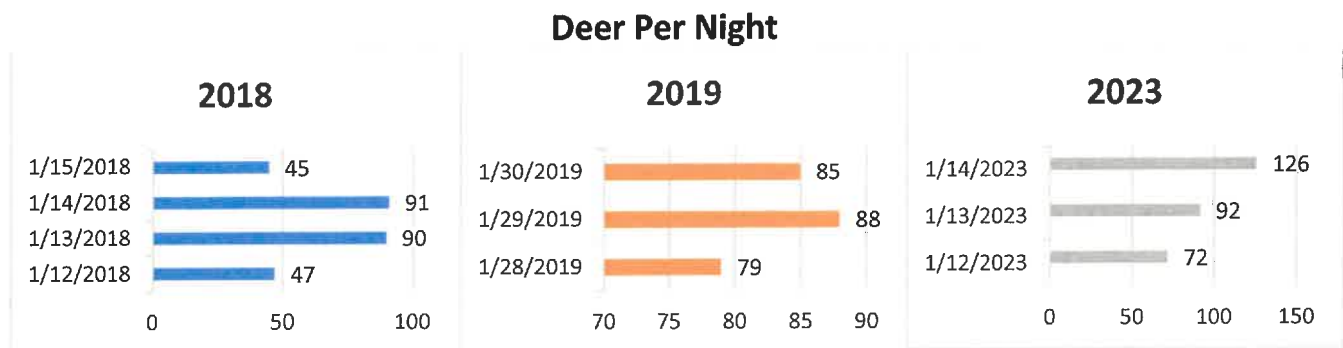
Over the course of the three days, 97 groups of deer were observed by the officers consisting of 290 total deer. In comparison, in 2019 there were 111 groups and 252 total deer. The White Buffalo Survey in 2018 concluded there were 108 groups with 273 total deer. The average number of deer per group were 2.99 deer compared to 2.27 in 2019 and 2.53 in 2018

These results were very similar to the observations made by the White Buffalo, Inc. personnel during their survey in 2018. The only noticeable variance in the two surveys was the number of deer observed in Zone 1. The number of deer observed by Chesterfield employees in that zone was 18 more deer overall than previously spotted by the White Buffalo, Inc employees. Astonishingly, the counts from zones 2 and 3 were nearly identical. Zone 3 has remained consistent over the course of 3 surveys with a count of 91. A complete comparison of the data, including detailed graphs are included in this report.

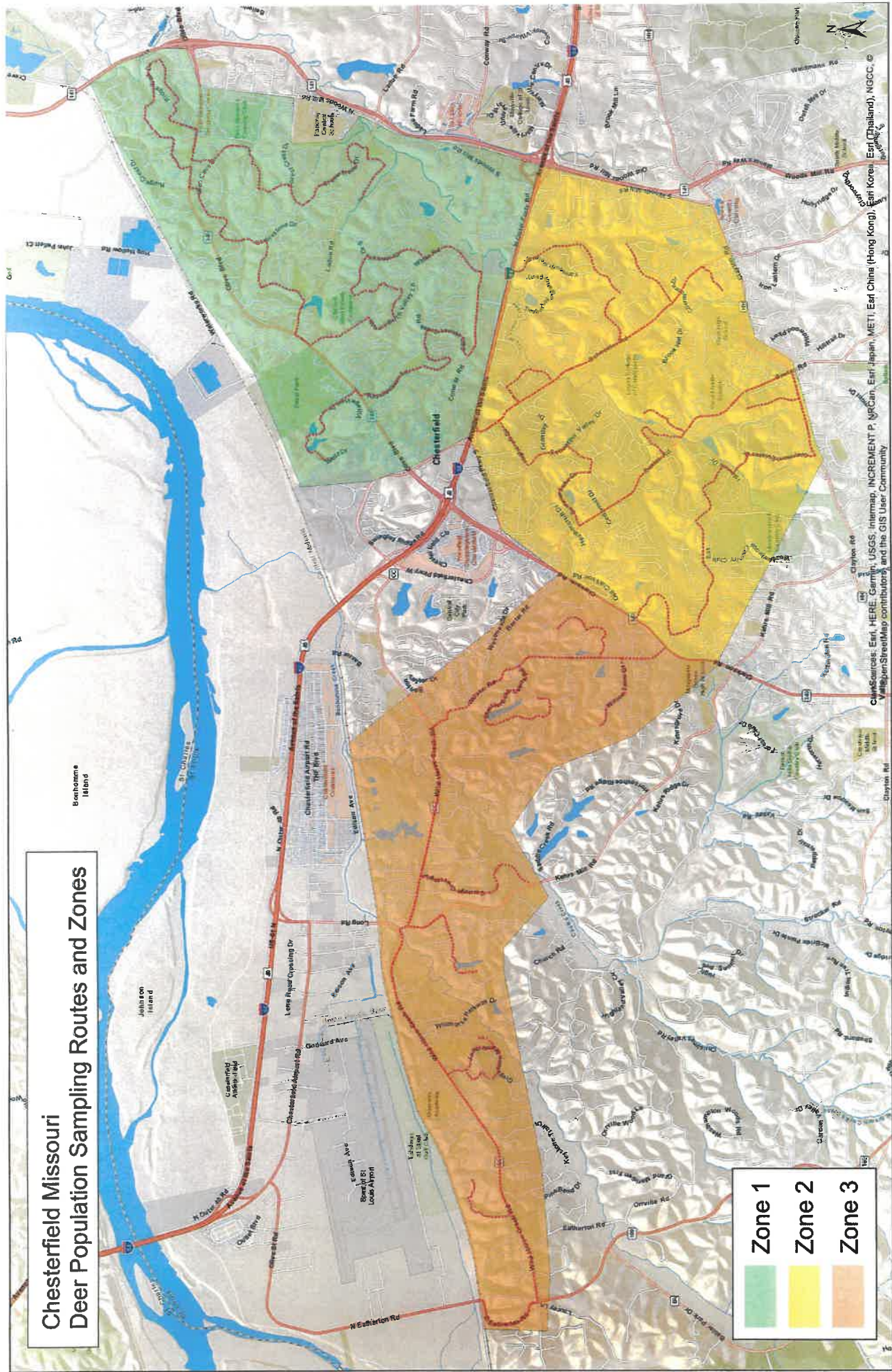

Honorable Nation:

The City of Chesterfield and St. Louis County are parties to an agreement for housing of municipal inmates at the St. Louis County Justice Center in Clayton ("Contract"). By Order dated November 15, 2022, the County Council approved an increase to the rate for such service. Consistent with the County Council's Order, the Contract will require amendment to increase the charge to \$50 per day. St. Louis County will prepare and send the necessary amendment.

No later than January 15, 2023, please provide the contact information (name and email address) of the individual authorized to sign the Contract amendment on behalf of your municipality.
