November 17, 2003

APPROVAL OF MINUTES

The minutes of the November 3, 2003, City Council meeting were submitted for approval. Councilmember Casey made a motion, seconded by Councilmember Durrell, to approve the City Council minutes. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

INTRODUCTORY REMARKS

Mayor John Nations announced that during an Executive Session, held prior to the City Council meeting, City Council adopted Ordinance No. 1984, which involves the City acquiring the right-of-way at/near the intersection of Wild Horse Creek Road and Kehrs Mill Road for use by St. Louis County and MoDOT in the construction of a “temporary fix” to the intersection of Wild Horse Creek Road, Kehrs Mill Road and Long Road. City Council also voted to appropriate \$30,000 from Fund Reserves to cover the cost associated with this acquisition. St. Louis County and MoDOT will spend a combined total of approximately \$300,000, for this “temporary fix”.

Mayor Nations announced that City Hall would be closed on Thursday and Friday, November 27 and 28, in observance of the Thanksgiving Holidays.

Mayor Nations announced that the next City Council meeting has been scheduled for Monday, December 1.

Mayor Nations next expressed sympathy to the families of Buzz Westfall, St. Louis County Executive, Ed Bax, City of Chesterfield Fleet Operations Manager and Ivis Johnston, former member of the Police Personnel Board. Everyone in attendance rose for a moment of silence, in honor of these individuals.

COMMUNICATIONS AND PETITIONS

Mike Doster, 17107 Chesterfield Airport Road, counsel to the petitioner, supported the rezoning of Appaloosa Way Subdivision Bill No. 2208 (P.Z. 29-2002).

Ellen Meyer, who resides at 1193 Nooning Tree Drive, expressed concern regarding the safety issues related to the traffic problems at the only entrance in and out of the Nooning Tree Subdivision and requested the City’s assistance in securing an additional entrance.

Aleta Marshall, who resides at 15234 Brightfield Manor Drive, expressed concern regarding the safety issues related to the traffic problems at the only entrance in and out of the Nooning Tree Subdivision and requested the City’s assistance in securing an additional entrance.

Jeannie Geers, 190 Carondelet Plaza, represented the petitioner and supported Bill No. 2210 (P. Z. 12-2003, Sheridan's Ice Cream Parlor).

COUNCIL COMMITTEE REPORTS

Finance and Administration Committee

Councilmember Jane Durrell, Chairperson of the Finance and Administration Committee, reported that there would be a Budget Workshop held November 19 at 6:30 p.m. to review the proposed FY2004 Budget.

Planning and Zoning Committee

Councilmember Barry Streeter, Chairperson of the Planning and Zoning Committee, reported that he would make a motion under his report to hold Bill No. 2166 (P.Z. 03-2003 – approves re-zoning – Montgomery Bank).

Councilmember Streeter next reported that Bill No. 2217 (P.Z. 10-2003 – Mill Ridge Villas (The Jones Company) will be read for the first time and Bill No. 2215 (approves a record plat for Lot 3 in Town Centre (Long Road), Bill No. 2216 (approves a record plat – Westchester Manor), Bill No. 2208 (P.Z. 29-2002, The Bluffs at Appaloosa Way), Bill No. 2209 (P.Z. 04-2003 – 14891 Olive Boulevard – CSP), Bill No. 2210 (P.Z. 12-2003, Sheridan's Ice Cream Parlor), Bill No. 2211 (P.Z. 18-2003, City of Chesterfield – deferred parking) and Bill No. 2212 (P.Z. 19-2003, City of Chesterfield – construction in existing residential) will be considered for adoption under the "Legislation – Planning Commission" portion of the agenda.

Councilmember Streeter announced that the next meeting of this Committee has been scheduled for November 20 at 5:30 p.m.

Public Health and Safety Committee

Councilmember Mike Casey, Chairperson of the Public Health and Safety Committee, reported that Bill No. 2214 (establishes three-way stop signs in a section of Wilson Farm Drive and Wilson Ridge Lane) will be read for the first time under the "Legislation" portion of the agenda.

Chairperson Casey next reported that Chief Johnson asked the Public Health and Safety Committee to consider two new ordinance requests that have been suggested by Prosecuting Attorney Tim Englemeyer. These two proposed ordinances would assist the Police Department in carrying out their duties. One proposed ordinance would make it unlawful for any person, while being taken into custody, arrested or while being issued a citation or summons to provide any false information. The other proposed ordinance would revise the Model Traffic Code to allow for the sentencing of those violators who drive with a suspended or revoked license. The Committee endorsed both proposed ordinances. City Attorney Beach is currently preparing both ordinances, for consideration by City Council at the December 1 City Council meeting.

Finally, Chairperson Casey reported that the Committee authorized the preparation of an ordinance which would establish school zones as special enforcement areas where it would be posted that fines for speeding violations, within these zones, would be doubled. This, also, will be forwarded to City Council for further consideration, at the December 1 City Council meeting.

Public Works/Parks Committee

Councilmember Connie Fults, Chairperson of the Public Works/Parks Committee, announced that the next meeting of this Committee has been scheduled for November 19 at 5:45 p.m.

REPORT OF THE CITY ADMINISTRATOR

City Administrator Mike Herring announced that there were no additional items requiring City Council review/approval.

NEW BUSINESS

Councilmember Geiger made a motion, seconded by Councilmember Streeter to direct Staff to develop a plan to acquire the Seeger property in order to develop a second entrance for Nooning Tree Subdivision. Discussion ensued. Mayor Nations stated that he has been working to acquire information, as previously directed/authorized by City Council, and has been in contact with Mr. Seeger, to discuss options for obtaining his property and developing a second entrance for the Nooning Tree residents. He suggested that the motion be amended to simply indicate that City Council continues to support efforts currently underway to gather information, for consideration by City Council, at some point in the future, regarding a possible second entrance, from Nooning Tree onto Olive Blvd. Both Councilmembers Geiger and Streeter agreed to this re-wording. The motion was then approved unanimously, as amended.

Councilmember Brown made a motion, seconded by Councilmember Casey, to add Item (w) to Section VII Verification Prior to Approval,

Item A which states that the City of Chesterfield is not responsible for the expense of future installation of sound walls. A roll call vote was taken with the following results: Ayes – Casey, Brown, Durrell and Geiger. Nays – Fults, Streeter, Flachsbart and Hurt. Mayor Nations broke the tie vote by voting “Aye.”

There being no further business to discuss, Mayor Nations adjourned the meeting at 8:22 p.m.
