BILL NO. 1468	AUTHORIZES THE EXECUTION OF A REDEVELOPMENT AGREEMENT AND OTHER RELATED ACTIONS IN CONNECTION WITH THE REDEVELOPMENT OF THE CHESTERFIELD COMMONS SUB-AREA (SECOND READING – FINANCE AND ADMINISTRATION COMMITTEE)

A motion was made by Councilmember Sheppard, seconded by Councilmember Flachsbart, to table Bill No. 1468 until additional information could be obtained regarding the St. Louis County Water Company and other public facilities as they relate to the building of a 500-year levee. A voice vote was taken with a negative result (Councilmember Flachsbart and Sheppard voted “Yes”) and the motion was declared defeated.

A motion was made by Councilmember Tilley, seconded by Councilmember Hurt, for a second reading of Bill No.1468. A voice vote was taken with an affirmative result (Councilmember Flachsbart and Sheppard voted “No”) and the motion was declared passed. Bill No. 1468 was read for the second time. A roll call vote was taken for passage and approval of Bill No. 1468 , with the following results: Ayes - Streeter,

Grosser, Hurt, Politte, Tilley and Brown. Nays - Flachsbart, Sheppard. Whereupon Mayor Greenwood declared Bill No.1468 approved, passed it and it became **ORDINANCE NO. 1342.**

BILL NO. 1483 AUTHORIZES THE ISSUANCE BY THE CITY OF CHESTERFIELD, MISSOURI OF TAX INCREMENT REVENUE NOTES, SERIES 1997 (CHESTERFIELD COMMONS PROJECT), TO PROVIDE FUNDS TO FINANCE CERTAIN REDEVELOPMENT PROJECT COSTS RELATING TO A TAX INCREMENT REDEVELOPMENT PLAN FOR A PORTION OF THE CHESTERFIELD VALLEY REFERRED TO AS THE CHESTERFIELD COMMONS SUB-AREA; AND APPROVES CERTAIN DOCUMENTS AND ACTIONS IN CONNECTION WITH THE ISSUANCE OF SAID NOTES (**FIRST AND SECOND READINGS - FINANCE AND ADMINISTRATION COMMITTEE**)

A motion was made by Councilmember Tilley, seconded by Councilmember Grosser, for the first reading of Bill No.1483. A voice vote was taken with an affirmative result (Councilmember Sheppard voted “No”) and the motion was declared passed. Bill No. 1483 was read for the first time.

A motion was made by Councilmember Sheppard, seconded by Councilmember Flachsbart, to table Bill No. 1483 until additional information could be obtained regarding the St. Louis County Water Company and other public facilities as they relate to the building of a 500-year levee. A voice vote was taken with a negative result (Councilmember Flachsbart and Sheppard voted “Yes”) and the motion was declared defeated.

A motion was made by Councilmember Tilley, seconded by Councilmember Hurt, to suspend the rules of Council to have both the second reading of this proposed ordinance at this Council meeting. A voice vote was taken with an affirmative result (Councilmembers Flachsbart and Sheppard voted “No”) and the motion was declared passed.

A motion was made by Councilmember Tilley, seconded by Councilmember Hurt, for a second reading of Bill No. 1483. A voice vote was taken with an affirmative result (Councilmembers Flachsbart and Sheppard voted “No”) and the motion was declared passed. Bill No. 1483 was read for the second time. Councilmember Sheppard expressed his opposition to having both readings at the same meeting. A roll call vote was taken for passage and approval of Bill No. 1483, with the following results: Ayes - Streeter, Grosser, Hurt, Politte, Tilley and Brown. Nays - Flachsbart, Sheppard. Whereupon Mayor Greenwood declared Bill No.1483 approved, passed it and it became **ORDINANCE NO. 1343.**

AMENDS THE ZONING ORDINANCE OF THE CITY OF CHESTERFIELD BY CHANGING THE BOUNDARIES OF AN "M-3" PLANNED INDUSTRIAL DISTRICT AND "NU" NON-URBAN DISTRICTS TO "C-8" PLANNED COMMERCIAL DISTRICT FOR A 128.5 ACRE-TRACT OF LAND LOCATED ON THE NORTH AND SOUTH SIDES OF CHESTERFIELD AIRPORT ROAD, EAST OF THE INTERSECTION OF BOONE'S CROSSING STREET (P.Z. 24-97, THE CHESTERFIELD DEVELOPMENT L.L.C./CHESTERFIELD COMMONS) (PLANNING AND ZONING COMMITTEE RECOMMENDS APPROVAL)

A motion was made by Councilmember Hurt, seconded by Councilmember Politte, for the first reading of Bill No. 1481. A voice vote was taken with an affirmative result (Councilmembers Sheppard voted "No") and the motion was declared passed. Bill No. 1481 was read for the first time.

A motion was made by Councilmember Hurt, seconded by Councilmember Politte, for a second reading of Bill No. 1481. A voice vote was taken with an affirmative result (Councilmember Sheppard voted "No") and the motion was declared passed. Bill No. 1481 was read for the second time. A motion was then made by Councilmember Brown, seconded by Councilmember Tilley, to amend Bill No. 1481 with the following amendments: 1) seasonal hours will be 6 a.m. to 12 midnight, Sunday, 6 a.m. to 1 a.m. Monday through Saturday; 2) all deliveries and trash pickup shall coincide with current City ordinance (7 a.m. to 6 p.m.); 3) all loading docks are to be screened by sound-proof materials as appears on site plan; 4) no retail sale store displays are permitted outside the main building except for live plants unless one side is attached to said building; 5) City Council shall exercise its power of review of the site plan. Discussion took place with regard to item 4. A revision was made to item 4 by stating that sidewalk sales are limited to live plants. Discussion followed regarding the hours of operation. A motion was made by Councilmember Sheppard, seconded by Councilmember Flachsbar, to amend the hours to reflect the same hours of operation (12 hours/day) as Chesterfield Mall. Discussion ensued. Councilmember Streeter called for the question. A voice vote was taken with a negative result (Councilmember Sheppard voted "Yes") and the amendment was defeated. Mayor Greenwood called for a vote on Councilmember Brown's amendments. A voice vote was taken with an affirmative result (Councilmember Sheppard voted "No") and the motion was declared passed. A roll call vote was taken for passage and approval of Bill No. 1481, as amended, with the following results: Ayes - Streeter, Grosser, Hurt, Politte, Tilley and Brown. Nays - Flachsbar, Sheppard. Whereupon Mayor Greenwood declared Bill No. 1481 approved, passed it and it became **ORDINANCE NO. 1344**.

BILL NO. 1477 CREATES A NEW ORDINANCE RELATIVE TO TREE PROTECTION AND TREE STANDARDS WITHIN THE CITY OF CHESTERFIELD (VERSION “B1”)

A motion was made by Councilmember Hurt, seconded by Councilmember Brown, for the first reading of Bill No.1477. A voice vote was taken with a unanimous affirmative result and the motion was declared passed. Bill No. 1477 was read for the first time.

A motion was made by Councilmember Hurt, seconded by Councilmember Brown, for a second reading of Bill No.1477. A voice vote was taken with a unanimous affirmative result and the motion was declared passed. Bill No. 1477 was read for the second time. A motion was made by Councilmember Flachsbart, seconded by Councilmember Politte, to replace Section 10 – Special Conditions. Much discussion ensued. Councilmember Streeter suggested that the bill be adopted and that changes could be made once it was in place. Additional discussion followed. A roll call vote was taken on Councilmember Flachsbart’s motion, with the following results: Ayes – Flachsbart, Hurt, Politte. Nays – Sheppard, Streeter, Grosser, Tilley, Brown. The motion was declared defeated. Councilmember Flachsbart requested that the Tree Ordinance (Bill No. 1477) be placed on the next agenda of the Planning and Zoning Committee. A roll call vote was then taken for passage and approval of Bill No. 1477, with the following results: Ayes - Sheppard, Streeter, Grosser, Hurt, Tilley and Brown. Nays - Flachsbart, Politte. Whereupon Mayor Greenwood declared Bill No. 1477 approved, passed it and it became **ORDINANCE NO. 1345**.

Council Committee Reports

Planning and Zoning Committee

Councilmember Dan Hurt, Chairperson of the Planning and Zoning Committee, reported that Bill Nos. 1467, 1474, 1475, 1478, and 1482 will be considered for adoption under the Legislation portion of the agenda.

Councilmember Hurt reported that Resolution No. 230 relates to various policy recommendations stemming from the Moratorium Panels. A motion was made by Councilmember Hurt, seconded by Councilmember Grosser, to adopt Resolution No. 230. A voice vote was taken with a unanimous affirmative result and the motion was declared passed. It was noted that these recommendations will be forwarded to and eventually discussed individually by the Planning and Zoning Committee.

Councilmember Hurt announced that the next meeting of this Committee has been scheduled for Nov. 20 at 5:30 p.m.

Finance and Administration Committee

Councilmember Linda Tilley, Chairperson of the Finance and Administration Committee, reported that due to recent changes to federal law, it will be necessary for the City to incorporate changes to the City’s Deferred Compensation Plan.

Resolution No. 229 reflects the changes mandated by federal law. A motion was made by Councilmember Tilley, seconded by Councilmember Brown, to adopt Resolution No. 229. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Councilmember Tilley next reported that Resolution No. 227 approves an additional five-month extension to the contract with the Chesterfield Community Development Corporation for consulting services with Mr. Lee McKinney. City Council had previously extended the contract for one month. A motion was made by Councilmember Tilley, seconded by Councilmember Brown, to adopt Resolution No. 227. A voice vote was taken with an affirmative result (Councilmembers Flachsbart and Sheppard voted “No”) and the motion was declared passed.

Councilmember Tilley next reported that the Committee recommends that the Department of Finance and Administration be authorized to extend the contract for auditing services with KPMG Peat Marwick to cover the audits for fiscal years 1997 and 1998, at an additional cost of \$2,000/year. A motion was made by Councilmember Tilley, seconded by Councilmember Brown, to extend the auditing services contract with KPMG Peat Marwick for audits in fiscal years 1997 and 1998. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Councilmember Tilley next reported that the Committee voted to recommend that Staff be allowed to administratively handle the approval of temporary liquor licenses for special events, which are usually one-day events and occur randomly throughout the year. Currently, City Council must approve temporary liquor licenses. A motion was made by Councilmember Tilley, seconded by Councilmember Grosser, to approve the policy to permit Staff to approve temporary liquor licenses. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Public Works/Parks Committee

Councilmember Barry Streeter, Chairperson of the Public Works/Parks Committee, reported that Bill Nos. 1466, 1472 and 1473, will be considered for adoption under the Legislation portion of the agenda.

Councilmember Streeter announced that the next meeting of this Committee has been scheduled for Dec. 9 at 7 p.m.

Public Health and Safety Committee

Councilmember Barry Flachsbart, Chairperson of the Public Health and Safety Committee, reported that Bill No. 1465 will be read for the second time and considered for adoption under the Legislation portion of the agenda.

Report of the City Administrator

City Administrator Mike Herring reported that a liquor license request has been received from Stromboli Ravioli, located at 125 B Long Road, to sell all kinds of liquor in the original packages not to be consumed on the premise. This business is a carry-out. The application has been reviewed and approved by the Police Department and the Department of Planning. A motion was made by Councilmember Politte, seconded by Councilmember Streeter, to approve issuance of the liquor license. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Mr. Herring next reported bids were recently sought for the purchase of an 80 ft. stainless steel salt conveyor, which will be used to maximize the full-storage capacity of the salt dome, located at the Public Works Maintenance Facility. After having reviewed these proposals, Mr. Herring joined with Mr. Geisel and Director of Finance and Administration Jan Hawn, in recommending approval of the low bid submitted by Kimco, USA for the purchase of this apparatus, totaling \$35,184.94. A motion was made by Councilmember Politte, seconded by Councilmember Flachsart, to accept the low bid submitted by Kimco, USA for the purchase of the salt conveyor at a cost of \$35,184.94. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Mr. Herring next reported that bids were recently sought for the purchase/installation of an overhead oil and lubrication system for our Public Works Maintenance Facility. After reviewing the information, Mr. Herring joined with Mr. Geisel and Ms. Hawn, Director of Finance and Administration, in recommending approval of the low bid submitted by Energy Petroleum, totaling \$7,953.17. This compares to the FY1997 budget amount of \$20,600 provided for this purchase. A motion was made by Councilmember Flachsart, seconded by Councilmember Streeter, to approve the low bid submitted by Energy Petroleum, totaling \$7,953.17. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Mr. Herring next reported that bids were recently sought for the purchase of two (2) asphalt emulsion tack distributors. He joined with Mr. Geisel and Jan Hawn, Director of Finance and Administration, in recommending approval of the low bid submitted by H. M. Dinzer Equipment Company, totaling \$15,000. This purchase is in keeping with current departmental practices and adequate funds exist within the current budget to accommodate this purchase. A motion was made by Councilmember Flachsart, seconded by Councilmember Hurt to approve the low bid submitted by H. M. Dinzer Equipment Company, totaling \$15,000. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Mr. Herring next reported that bids were recently sought for miscellaneous sewer joint repairs to be accomplished during calendar year 1998. The proposed budget for FY1998 includes an allocation of \$206,000 for unspecified sewer repairs city-wide. No cost would be incurred nor will any contracts be signed until after January 1, 1998, when the new budget takes effect. After reviewing this information, Mr.

Herring joined with Mr. Geisel and Director of Finance and Administration Jan Hawn in recommending approval of the bid submitted by Waste Management Precision Services for various hourly rates associated with stormsewer join repairs to be accomplished in 1998. A motion was made by Councilmember Flachsbart, seconded by Councilmember Politte, to approve the bid submitted by Waste Management Precision Services for various hourly rates associated with stormsewer join repairs. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Mr. Herring next reported that additional expenses were incurred in conjunction with the contract originally awarded to Vee Jay Cement Contracting Company, for work associated with the passage of Propositions "R" & "S." The original contract awarded to this company totaled \$1,409,000. It is the recommendation of Mr. Geisel with concurrence from Director of Finance and Administration Jan Hawn, that this contract be increased by a total dollar amount of \$67,565, bringing the new total contract authorization to \$1,476,565. There is no need to transfer any funds, since the entire amount is covered by proceeds resulting from the approval of Propositions "R" & "S." A motion was made by Councilmember Flachsbart, seconded by Councilmember Sheppard, to approve a change order reflecting additional expenses incurred with regard to work undertaken in Area "A" at a total cost of \$67,565. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Mr. Herring next reported that the current budget needs to be adjusted to reflect actual revenues received and expenditures made by the City, as of the end of the third quarter. All of these adjustments are handled internally, within the context of the existing budget and there is no need to allocate additional funds to cover the expenses noted. Mr. Herring joined with Director of Finance and Administration Jan Hawn in recommending that the FY1997 Budget be adjusted to reflect changes in revenues and expenditures as detailed in Ms. Hawn's memo which is attached. A motion was made by Councilmember Flachsbart, seconded by Councilmember Grosser, to approve the budget adjustments. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

A roll call vote was taken for passage and approval of Bill No. 1465 with the following results: Ayes - Flachsbart, Sheppard, Streeter, Grosser, Hurt, Politte, Tilley and Brown. Nays - None. Whereupon Mayor Greenwood declared Bill No. 1465 approved, passed it and it became **ORDINANCE NO. 1346**.

BILL NO. 1466 PERTAINS TO THE ACCEPTANCE OF THE PUBLIC STREET KNOWN AS CHESTERFIELD CENTER EAST IN THE CITY OF CHESTERFIELD (**SECOND READING** – PUBLIC WORKS/PARKS COMMITTEE)

A motion was made by Councilmember Streeter, seconded by Councilmember Grosser, for a second reading of Bill No. 1466. A voice vote was taken with a unanimous affirmative result and the motion was declared passed. Bill No. 1466 was read for the second time. A roll call vote was taken for passage and approval of Bill No. 1466, with the following results: Ayes - Flachsbart, Sheppard, Streeter, Grosser, Hurt, Politte, Tilley and Brown. Nays - None. Whereupon Mayor Greenwood declared Bill No. 1466 approved, passed it and it became **ORDINANCE NO. 1347**.

BILL NO. 1472 PERTAINS TO THE ACCEPTANCE OF PUBLIC STREETS WITHIN TWIN ESTATES AT SYCAMORE RIDGE SUBDIVISION IN THE CITY OF CHESTERFIELD (**FIRST READING** - PUBLIC WORKS/PARKS COMMITTEE)

A motion was made by Councilmember Streeter, seconded by Councilmember Politte, for the first reading of Bill No. 1472. A voice vote was taken with a unanimous affirmative result and the motion was declared passed. Bill No. 1472 was read for the first time.

BILL NO. 1473 APPROVES THE INSTALLATION OF FIRE HYDRANTS IN LOT 1, SPIRIT 40 PARK AND TARA AT WILDHORSE LOCATED WITHIN THE CITY OF CHESTERFIELD (**FIRST AND SECOND READINGS** - PUBLIC WORKS/PARKS COMMITTEE)

A motion was made by Councilmember Streeter, seconded by Councilmember Politte, for the first reading of Bill No. 1473. A voice vote was taken with a unanimous affirmative result and the motion was declared passed. Bill No. 1473 was read for the first time.
