 - A. **YMCA Updates** – everybody
 - 1. Tabletop Week of Oct. 10 (put up date) – Oct. 14 (take down date); Donna reported its reception was stellar.
 - 2. Wed., Oct. 12, 6:30 P.M. – 7:30 PM free Pollinators Program @ YMCA's Theater; Chris Hartley was the presenter; presentation went very well from all accounts. 300+ Pure Air Native's wildflower seed packs were given away; 75 NWF Butterfly Heroes Kits given away; 26 people mostly from St. Louis County and Chesterfield, but also St. Louis City and St. Charles County. Compliments to Donna and Jeanne C. who made the tabletop so successful.
 - 3. Sat., Oct. 15, planting native flora for butterflies/pollinators @ YMCA, back side of building was very successful. Unanimous decision to do another segment there next year, same time.
 - 4. Garden to be NWF Certified; *Visitor*: Executive Director Denise Glass to present to us if possible, but she couldn't make it; we voted to process. Darcy and Polly met with RGA rep but the company decided not to do anything until the first of the year and then try to get it approved from corporate.
 - 5. Follow-up with Sachs Library for their NWF Application.
 - B. **Invasive Bush Honeysuckle Eradication, Oct. 22 @ Faust Park.** Three Girl Scout troops plus the Boy Scouts; plus many CCE members and Guy Tilman. We

collected five dump trucks of removed IBH. We intend to repeat the effort next year.
