- I. Call to Order @ 6:17** (It was noted by many CCE members that they had not received or had not been able to open the email notice of the meeting with agenda and minutes attached. If received it could not be forwarded. The Chair (Darcy) did not receive email notice.)

- III. Approval of August 24, 2017, Minutes.** Motion by Polly, 2nd by Laura, passed unanimously.
- IV. Presenter Robert Sears, President of Eastern Missouri Beekeepers:** Overview and how to ‘gather’ Chesterfield Beekeepers for Earth Day “swarm.” (15 min.) Mr. Sears was very impressed by our committee. Ted Jansen was his mentor from 1992. Beekeepers started over 100 years ago. They present educational programs with mini workshops and guest speakers and host an annual program to educate beginners and help them get started. This program will be in Feb. at Maritz. They have worked with St. Louis Earth Day and Chesterfield ED, in the past. They would like to continue selling honey at our ED event. They prefer selling at ED, rather than retail. At our ED Mr. Wagner will be representing beekeeping also. Mr. Sears suggested contacting Joyce Steenger/Steenger’s Honey – to come to our ED with her wares, (candles, etc.) Their website is “easternmobeekkeepers.com” He asked if we have a “Pollinator Improvement Program” in Chesterfield. (We do.) MO Master Pollinator Program will be kicking off later this year thru the MO Dept. of Agriculture. He also suggested that we go to “Honeybeehealthcoalition.org” and then go to Nutrition Challenge. A lot of money will be awarded to the winner of this challenge. Monsanto is trying to find non chemical ways to use to help protect the butterflies & bees. Community based programs, like ours, are the most important to protect the bees.
