LEGISLATION

BILL #723 AN ORDINANCE PROVIDING FOR THE APPROVAL OF THE
RECORD PLAT, ESCROW AGREEMENT AND WARRANTY
DEED FOR BROOK HILL ESTATES PLAT FOUR, A
SUBDIVISION LOCATED ON THE WEST SIDE OF
SCHOETTLER ROAD, NORTH OF CLAYTON ROAD

A motion was made by Councilmember Hathaway, seconded by Councilmember Hrabko, for the first reading of Bill #723. A voice vote was taken with a unanimous affirmative result and the motion was declared passed. Bill #723 was read for the first time.

A motion was made by Councilmember Hrabko, seconded by Councilmember Levinson, for a second reading of Bill #723. A voice vote was taken with a unanimous affirmative result and the motion was declared passed. Bill #723 was read for the second time. A roll call vote was taken for passage and approval of Bill #723, with the following results: Ayes - Hathaway, Clarke, Levinson, Hrabko and Tilley. Nays - None. Whereupon Mayor Leonard declared Bill #723 approved, passed it and it became ORDINANCE #711.

REPORT OF THE CITY CLERK

City Clerk Marty DeMay reported that the City had received two temporary liquor license requests to served beer and wine at the French Festival to be held at Faust Park, located at 15185 Olive Boulevard, September 20, 1992.

The application submitted by Park Ridge Management, Inc. has been reviewed and approved by Chief of Police Ray Johnson and Director of Planning Jerry Duepner. A motion was made by Councilmember Clarke, seconded by Councilmember Levinson, to approve issuance of the temporary liquor license. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

Due to the St. Louis - Lyon Sister Cities, Inc. submitting their application shortly before the City Council meeting was called to order, no approvals have been obtained. A motion was made by Councilmember Hrabko, seconded by Councilmember Levinson, to approve issuance of the temporary liquor license with the stipulation that the application be reviewed and approved by Chief of Police Ray Johnson and Director of Planning Jerry Duepner. A voice vote was taken with a unanimous affirmative result and the motion was declared passed.

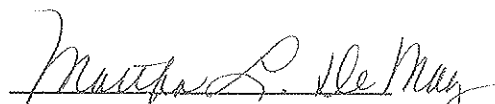
ADJOURNMENT
