III Presenter: Chris Hartley, Director of Science/Butterfly House & NWF Community Habitat Partner. Chris gave us an updated flyer and brochure and presented an overview of their continuing project: Project Pollinator, a community garden initiative, in which The Butterfly House is partnered with St. Louis County Parks, St. Louis County Library, and Greenscape Garden and Gifts. The mission of Project Pollinator is to promote an appreciation of **all** pollinators through education and the creation of pollinator gardens. In addition, Chris handed out “our” flyer to promote “our” free presentation at the Chesterfield YMCA celebrating Pollinators on Wednesday October 4, 6:30-7:30 p.m. He is going to add the garden layout onto the back of the flyer.

- Paul asked about the about the tall grass prairie at Faust Park and Chris updated us on it. Our Grow Native! Demo garden is was overtaken by invasive plants, that has been addressed and it looks neat at this point. But the garden area will need to winter, and we can replant native plants in April, 2018.

C. SLCDOHWMGroup Pilot Project Grant – Tom , Darcy, Su , Jeanne T.

1. Republic's volume from 7/17 both recyclables and landfill this month and last month were not available for "our" Grant baseline.
2. Recyclables from bathroom area flyer complete and will be distributed at the next Party Off the Parkway.

3. "All-in-One" Recycle Flyer, second side for 'concessions recyclables'. There was a mistake made when printing the flyer so it will be corrected and reprinted.
4. "Coaching the Coaches", Jeanne T get the flyer to Ascension Soccer and ask that it be forwarded to the coaches and the team families.
5. Talking points for this Grant/for Tom to pronounce: The committee will begin brainstorming talking points we think are important for Tom to mention when he addresses the audience at the Chesterfield Amphitheater next spring/summer.

3. The butterfly sculpture at Eberwein Garden has not been repaired/replaced.

E. NWF – Darcy, Tom

1. We are looking to improve the Mayor's Monarch Pledge in a business native garden.
2. NWF Fiscal Report summary; filed 7/17/17. Should hear 8/18/17 & we did it!
3. The national Telephone Conference scheduled for 8/8/17 was cancelled and has not been rescheduled yet.
4. Darcy will attend the CFM Affiliates Summit in mid-September, and asked to use CCE Powerpoint there. All members approved.
5. CLC topic recommendation was approved. (Suggested: standardize, uniform recycling practices code to apply throughout state parks & to include standardized R & L units with visual guidance; has to be verified with communities where state parks are, Solid Waste Mgmt. Districts, DNR & MORA. No littering, dumping, etc.) DRAFT due 9/28/17, CCE Meeting; due 10/6/17!
6. October YMCA: 150 donated native flora seed packets coming in for Library and Y use/tabletop. Did not want a donation. Plus 3 flats for metamorphosing Y butterfly garden; Chris H. coordinating.
7. It was approved for Tom to give IBH brochure to all Subdivision Trustees at the meeting on September 13th at City Hall. It was also suggested that Tom use opportunity to encourage the trustees to actively engage their subdivision to eradicate invasive honeysuckle in their neighborhood.
8. Parks recycling flyers should be made available on 9/13/17 for the subdivision trustees.
