- A. **Greystone Subdivision**; Planned Environment Unit (PEU) Procedure in the "R-1" One Acre Residence District and "FPR-1" Flood Plain "R-1" One Acre Residence District Record Plat, Plat 1; south side of Wild Horse Creek Road, west of Wildhorse Parkway.

Assistant Director of Planning Laura Griggs-McElhanon presented the request and the Department's recommendation for approval.

A motion for approval was made by Chairman Casey, seconded by Commissioner Kenney and passes by a voice vote of 5 to 0.

- B. **The Villas at Chesterfield Bluffs Plat 2 (Chesterfield Farms Multi-Family)**; Subdivision Record Plat in the "R-2" 15,000 square foot and "R-6" 4,500 square foot Residence Districts; west side of Baxter Road, north of Chesterfield Farms Drive.

Assistant Director of Planning Laura Griggs-McElhanon presented the request and the Department's recommendation for approval.

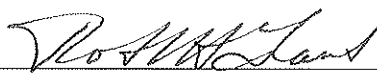
A motion for approval was made by Chairman Casey, seconded by Commissioner Grant and passes by a voice vote of 8 to 0.
