1. Jim Pisoni called meeting to order at 6:15 pm
2. Roll Call.
3. March 13, 2024 meeting results were reviewed, amended and approved.
4. Department Updates
 - a. 2024 Preview – Sports and Wellness Division. Ethan Collier provided an update on the various Sports and Wellness programs in process along with the baseball/softball tournament schedule at CVAC.
5. Unfinished Business
 - a. Amphitheater BOH and restroom update – Cost estimates are nearly complete and within the approved budget. Design and construction documents are nearly 90% complete. Construction should begin in fall/winter 2024 and complete by spring 2025.
 - b. Archery Range – Project was abandoned due to increased costs at the proposed location by the shooting range. Additional costs identified include existing berm repair, parking, roadways, and MSD requirements.

- c. Central Park playground – Replacement of the existing playground is being considered if a grant is awarded and funding approved. This is currently in the conceptual design phase.
 - d. Chesterfield Family Aquatic Center – Repairs are being made, and preparation is in process for opening day May 25, 2024. Seasonal hiring is nearly complete, but a few openings remain for lifeguards and aquatic aides. Staff will begin pursuing facility replacement options per direction from City Council.
 - e. CVAC – Season is in full swing. Tournament schedule was shared with the committee.
 - f. Logan Park – PRACAC unanimous recommendation to locate the 2024 Sculpture on the Move, “Gotta Practice,” is on the May 22 PRA Committee of Council meeting agenda. If approved, it would then go to City Council for final approval, likely in June.
 - g. QR codes for pavilions and sculptures – Staff is researching options for those on city property.
6. New Business
- a. Public Art Highlights - “Flow” and “The Fox” were presented.
 - b. Volunteer Opportunity – Stars and Stripes Run on July 4, 7:30-11:00 AM at CVAC.
 - c. Ward III Vacancy – TW confirmed that there is a Ward III vacancy for PRACAC.
7. Announcements.
- a. Summer Citizen Newsletter – Expected to mail on May 22.
 - b. SeeClickFix “Report a Problem” - This is a new work order system for citizens to report problems to the City. It is expected to go live May 23.
 - c. CFAC opens on May 25.

Subject: updates

Archery range

- Originally an ARPA funded project estimated around \$40,000
- Estimate an additional \$275,000+ would be needed to complete project
- Project abandoned due to increased costs

Amphitheater

- June 4 meeting summary
 - Design & construction documents 90% complete
 - Updated cost estimates (see below)
 - Current construction estimated late September 2024 through June 2025
 - Likely proceed without restroom & canopies as bid-alternate due to high estimates
- Bond Architects cost estimates as of June 4, 2024 (90% document completion)
 - Cost estimates at 90% came in considerably higher than at the 50% mark in February. Below is are current estimates, including Furniture, Fixtures & Equipment (FF&E)
 - Back of House (BOH), Canopy, & Restroom: \$ 3,558,684 + 74,456 (FF&E)
 - BOH, both Canopies (no restroom): \$ 2,708,707 + 74,456 (FF&E)
 - BOH, north Canopy only (no restroom): \$ 2,419,922 + 74,456 (FF&E)
 - BOH only (no canopies, no restroom): \$ 2,081,847 + 74,456 (FF&E)
 - Current budget: \$ 2,300,000

- Proceeding with RD25 MUNI grant application (separate agenda item)

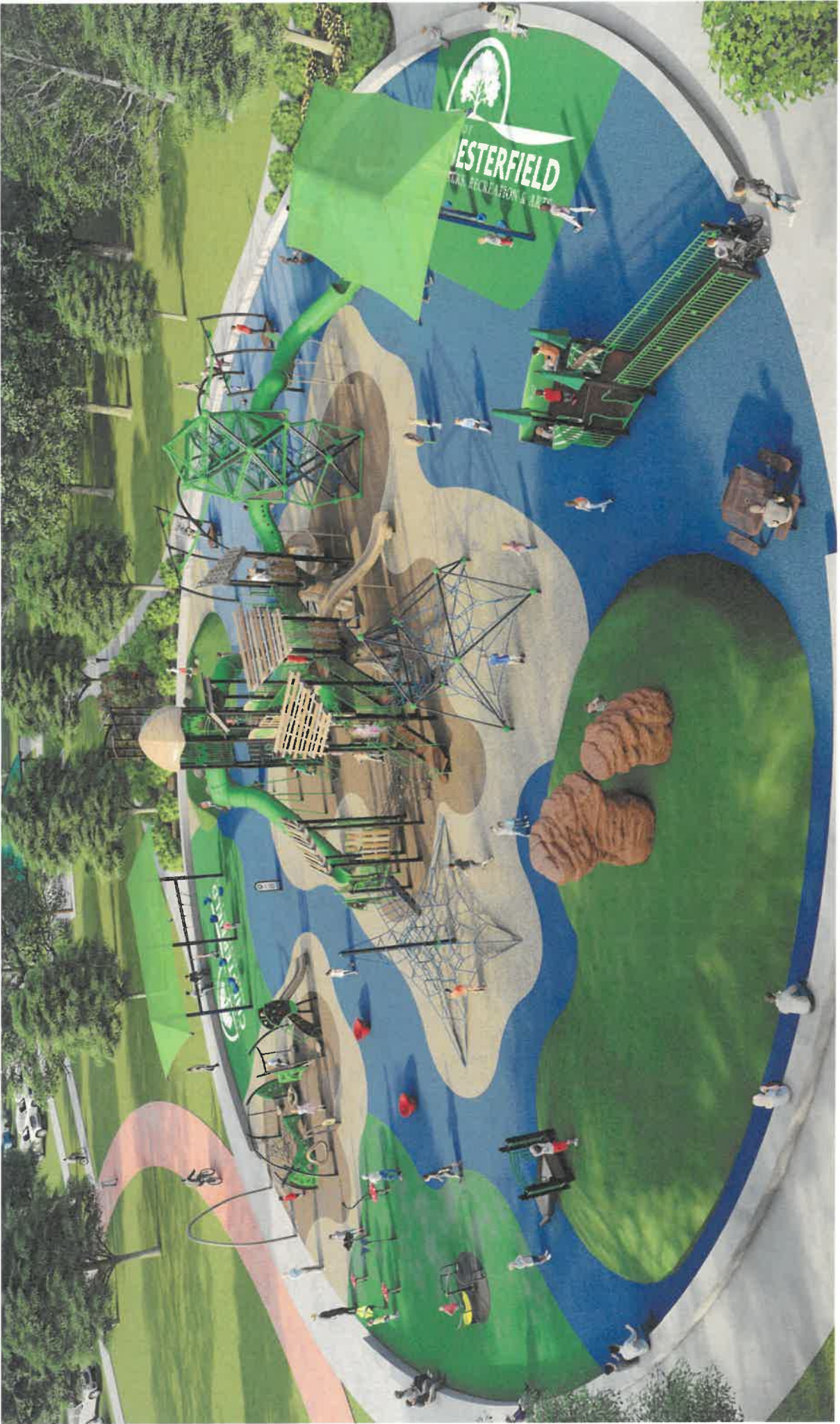
Chesterfield Family Aquatic Center (CFAC)

- Opening day May 27 saw 599 visitors. June 2 – 508. June 3 – 541. June 6 saw 705 visitors. Many were families and season pass holders.
- June 1 - August 11 (noon – 7pm M-F, noon - 6:30pm Saturdays/Sundays/holidays)

Chesterfield Valley Athletic Complex (CVAC)

- Old playground & surface removed week of May 27 – 31. New installation began June 3.
- New Miracle Field surface starts July 8. Should be ready by July 29.
- New Perry Weather Alert System is working well for safety-inclement weather and PSAs.
- Perfect Game sponsorship proposal for six electric charging stations moving forward.
