- A. [BILL NO. 2694](#) AMENDS ORDINANCE NUMBER 35, SCHEDULE IX, OF THE ORDINANCES OF THE CITY OF CHESTERFIELD, BY AMENDING PROVISIONS THERETO REGARDING THE RESTRICTION OF PARKING ON COUNTRY RIDGE DRIVE, EAGLE POINT COURT, FEDERAL WAY, SYCAMORE HILL COURT AND WILLOW FOREST COURT (**SECOND READING - PLANNING/PUBLIC WORKS COMMITTEE RECOMMENDS APPROVAL**)
