1) **Approval of Minutes** - Darcy motioned approval of minutes, Mike second, approved.

2) **Future projects and long range goals/priorities**

- update of Master Plan (from 2010)

Alan made a motion to formally develop Railroad Park (RRP), Mike 2nd
Discussion

- Darcy pointed out value of habitats, Girl/Boy Scouts
- Cindy suggested we table and review priorities before making decisions
- 33 acres at RRP, but there are both access and flood issues, extensive bridge would be needed (Tom has spoken with an engineer about the bridge)
- 17 acres on the west end (not owned by the city) worth evaluating acquisition as it provides more parking, better access and potential for pavilion and restrooms
- Kimberly asked why this RRP is a viable priority due to access issues, flooding issues, lack of parking, etc.
- Alan conveyed RRP this is an area worth investigating as it would be ideal for pavilions
- Motion is tabled until next month while Tom brings in more information

City Council priorities

- River's Edge was the biggest priority last year
- Evaluating parks in northern section of the city remains a need
- Barry - most all parks and park land is in Ward 4, desire to acquire more land while it remains available, but no immediate priority

Michelle – Retreat recap

- New ideas for park development (River's Edge, RRP & Pavilion)
- Volunteer needs expanded

Barry - suggested we evaluate RRP to review opportunities.

Alan agrees. He believes this is a multi-year process

Tom – Bringing a bridge into RRP is possibly a municipal grant project for 2017

Barry asked about the activity for pursuing the other 17 acres

Kimberly- Is Eberwein NOT considered for a pavilion due to parking and location?

Tom- Yes, parking issues....neighbor's would be unhappy and additional parking would create a lot of concrete

John N. - Eberwein is exactly what it is used for (open space to toss a frisbee, dog park and 53 community garden plots)
